ANNUAL ROAD TAX REGISTRATION



Annual Road Tax Registration

Every motor vehicle owner using a public road is required to pay an annual road tax. Road tax is governed under Section 34 of the Road Traffic Control Act [Cap 29].

How much is the road tax?

Road Tax is based on the cylinder capacity (cc) and tonnage or payload. Refer to schedule Table 1.1

When is road tax due?

Road tax is due on or before the 31st of March every year. Payments made in April will attract a penalty of 25% and from May 50%.

What must I do before paying my road tax?

Before any road tax payment can be made, the following documents must be provided;

- Vehicle Registration Book reflecting the current owner.
- Road Worthiness Certificate.

Road Worthiness Test fees are to be paid at the central government cashier, Department of Finance BEFORE inspections can be made at designated PWD workshops. Every vehicle is required to have at least a third party insurance.

My road tax sticker was stolen from my car? How do I get another one?

It will cost you the same amount to get a replacement.

Vehicles involved in an accident would require a police report.
