Sale of liquor is a restrictive business activity that reguires a liguor licence and is administered under Liguor Licensing Act (CAP 52) of 1969.

How do I obtain a liquor licence?

The process requires approval from three different authorities namely; Port Vila Municipal Council; Police; and the Minister of Internal Affairs.

The first step is to submit a liquor licence application to Port Vila Municipal Council and they will facilitate the latter approvals.

Once approval is granted, lodge the application at Taxpayer Services Section.

The same process will apply for renewal of licence. Application forms are available at the Taxpayer Services Office in Port Vila, Luganville and Lenakel or it can be accessed from the website: https://customsinlandrevenue.gov.vu

How much does the liquor licence cost?

There are 18 different liquor licence categories with varving fees listed in Appendix 1.

Fees for new licences approved after 31 January will be assessed on pro-rata basis.

How long is a liquor licence valid for?

Licences are valid until 31 December and are subject to renewal on or before 31 January of the following year.

What is the penalty fee for liquor licence renewals?

The applicant has up to 30 days to pay the licence fee (s) after approval is granted. A penalty fee of 10% per month will be charged after 30 days and if payments are not made after 3 months, the licence will be cancelled.
